- **3** Consider whether each of Chris, Lee and Adil are liable for a non-fatal offence against the person in the following situations. Do **not** consider any defences.
 - (a) Chris is a stunt man. He is working on a film where he has to take part in a fight scene with another stunt man, his good friend Steve. The fight scene uses real swords. On the day of the filming of the fight scene Chris is tired as he has not been sleeping very well. Before filming the scene he is asked by Steve to take part in a practice fight using wooden swords. However, Chris decides to use his real sword as he thinks his sword skills are perfect. During the practice, Chris swings his sword at Steve in an awkward way and cuts off Steve's hand.

 - (b) Edith is elderly and lives alone. Over the last few weeks she has received several disturbing telephone calls, where the person making the calls either remains silent or makes strange noises. The calls are upsetting her and making her very frightened. The person making the calls is in fact her teenage grandson, Lee, who thinks it is very funny. Early one morning, Lee telephones Edith and when she answers all she can hear is Lee's heavy breathing. Edith still does not know that it is Lee making the call and she panics, then faints and remains unconscious for three minutes.
 - (c) Tanya is on a train on her way to work. The train is busy but there are several seats available. Adil gets on the train and stands next to Tanya because it is his favourite spot and he likes to look out of the window. Tanya is blind. To steady himself, Adil grabs hold of an overhead handrail, but in doing so his elbow rests against Tanya's face. Tanya asks him to move his elbow but Adil shouts: "Shut up! You'll have to wait until I get off at the next station!" When the train arrives at the next station, five minutes later, Adil moves his elbow leaving a red mark on Tanya's face which disappears in a very short time.
