## **General Marking Guidance**

- All candidates must receive the same treatment. Examiners must mark the first candidate in exactly the same way as they mark the last.
- Mark schemes should be applied positively. Candidates must be rewarded for what they have shown they can do rather than penalised for omissions.
- Examiners should mark according to the mark scheme not according to their perception of where the grade boundaries may lie.
- There is no ceiling on achievement. All marks on the mark scheme should be used appropriately.
- All the marks on the mark scheme are designed to be awarded.
   Examiners should always award full marks if deserved, i.e. if the answer matches the mark scheme. Examiners should also be prepared to award zero marks if the candidate's response is not worthy of credit according to the mark scheme.
- Where some judgement is required, mark schemes will provide the principles by which marks will be awarded and exemplification may be limited.
- When examiners are in doubt regarding the application of the mark scheme to a candidate's response, the team leader must be consulted.
- Crossed out work should be marked UNLESS the candidate has replaced it with an alternative response.

	AO2 requires candidates to develop their answers showing analytical and evaluative skills to address the question. Such responses will be underpinned by their use of knowledge and understanding.
	<ul> <li>Candidates may refer to the following in relation to AO2.</li> <li>Moses is significant because some of the revelations to him reflected attributes of God.</li> <li>Moses is significant because of his role in the Exodus.</li> <li>A key factor of the status of Moses is his reception of the Decalogue, given that this is central to Jewish belief.</li> <li>Candidates may analyse interrelated themes because of their pre-eminence in this context such as Torah and Jewish identity.</li> </ul>

	If candidates analyse just one response they cannot normally proceed beyond level 3.		
	For the purposes of this mark scheme Orthodox Judaism is selected as one response and Fackenheim (Reform) as the second. This illustrates the range of legitimate responses.		
	AO1 will be used by candidates to underpin their analysis and evaluation. Candidates will be required to demonstrate knowledge and understanding using specialist language and terminology when responding to the question, and in meeting AO2 descriptors described below.		
	<ul> <li>Candidates may refer to the following in relation to AO1.</li> <li>Some Ultra-Orthodox Jews consider that the Holocaust was a punishment for sin.</li> <li>For some Jews this is evidence for the death of God.</li> <li>Many Jews would consider that the Holocaust symbolises the idea of the suffering servant.</li> </ul>		
	AO2 requires candidates to develop their answers showing analytical and evaluative skills to address the question. Such responses will be underpinned by their use of knowledge and understanding.		
	<ul> <li>Candidates may refer to the following in relation to AO2.</li> <li>The wholesale destruction of Jews and their religion and culture is critical in this context because this determined various theodicies and secular responses.</li> <li>One notable Orthodox response is to accuse Reform movements of being indirectly responsible because assimilation increased anti-Semitism.</li> <li>Some links between Orthodoxy and Zionism were formed, including Zionist Orthodox theology and these argue that this combination adds to the development of Judaism.</li> <li>In the context of the Holocaust there is a radical departure from Orthodoxy towards secular Judaism because of the need to understand the problem of evil.</li> <li>Fackenheim had some first-hand experience of Nazi Pogroms and this is significant because he did not want to give Hitler a posthumous victory and hence his views lead to the significance of 614 commandments.</li> </ul>		
	<ul> <li>Fackenheim's moral imperative stresses the continuing survival     of the Jewish people because this shows the on-going work of     God.</li> <li>Candidates who show achievement only against AO1 will not be able to gain marks     beyond the top of Level 1.</li> </ul>

Some Jews maintain their liberal identity while cherishing traditional Orthodox practices.
	AO2 requires candidates to develop their answers showing analytical and evaluative skills to address the question. Such responses will be underpinned by their use of knowledge and understanding.
	<ul> <li>Candidates may refer to the following in relation to AO2.</li> <li>Candidates may explore a range of interpretations relating to Jewish identity because this theme underpins the question.</li> <li>Orthodoxy may claim to have the distinctive features of Jewish identity because this is based on the God-given Torah.</li> <li>The distinctive Orthodox practices in synagogues and religious observances in the home are significant because they claim to be the hallmarks of Jewish identity.</li> <li>Reform's changes of beliefs and practices over time are critical to Jewish identity because these illustrate different emphases.</li> <li>Reform, as a liberal religious movement, has strengths and weaknesses because of its willingness to develop and change its self-identity.</li> <li>Developments in Judaism may be linked with the work of key critiques about the existence of God. (This shows links with Philosophy of Religion).</li> <li>Developments in Judaism may be linked to meta-ethics including debates about ethical language as seen in Orthodox and Reform debates (This shows links with Religion and Ethics).</li> <li>Developments in Judaism in relation to inter-faith issues, such as the relationships between Jesus and Jewish authorities can be explored. (This shows links with New Testament Studies).</li> </ul>
